- Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on election day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) may 1) have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by June 10, Noon. Election Day Registrant attestors must provide an approved form of identification. There will be satellite polling locations within Scott County and all ballots will be available at each site. Below are the details:
- Bettendorf Public Library, 2950 Learning Center Campus on May 23 from Noon to 6 p.m. and May 24 from 9:30 a.m.-3:30 p.m.
 - Also, voting will be available in the Auditor's Office: In-person early voting at the Auditor's Office begins on Wednesday, May 15 and runs through Monday, June 3, and will be available Monday – Friday, 8:00 a.m. to 4:30 p.m. and Saturday, June 1, 2024 from 8:00 a.m. to 4:00 p.m. This special Saturday voting will be located in the Board of Supervisors Room on the first floor. The Post-Election Audit is scheduled for Friday, June 7 at 9:30 a.m. and will take place at the Scott County Administration Center, 600 W. 4 Street, Davenport.
- Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle. - Attempting to Vote more than once is a crime: Iowa Code Section 39A.2(3)** A person commits the crime of election misconduct in the FIRST DEGREE if the person willfully votes or attempts to vote more than once at the same election, or votes or attempts to vote at an election knowing oneself not to be qualified.
