I know that I cannot be a candidate for more than one office to be filled at this election, except as otherwise provided by law.

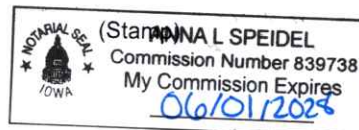
